AN ORDINANCE

**AUTHORIZING THE PLACEMENT OF STOP
SIGNS AT THE INTERSECTIONS OF HINES ROAD
AND WAUMSETT AVE AND HINES ROAD AND
PEQUOT AVE**

The Town of Cumberland ordains:-

Section 1. Section 36(a) in Chapter 38 of the Town of Cumberland Code of Ordinances entitled "Traffic and Vehicles" is hereby amended by adding thereto the following language:

[Stops on:] [Intersection with:]

Hines Road, both directions **Waumsett Avenue**

[Stops on:] [Intersection with:]

Waumsett Avenue. **Hines Road**

[Stops on:] [Intersection with:]

Hines Road, both directions **Pequot Avenue**

[Stops on:] [Intersection with:]

Pequot Avenue. **Hines Road**

Section 2. The Director of Public Works, through his office, shall see that signs are posted in this area so designating the restrictions.

Section 3. This Ordinance shall take effect immediately upon its passage and all ordinances or provisions of Ordinances which are inconsistent herewith are hereby repealed.

EXPLANATION

This ordinance authorizes the placing of stop signs on Hines Road in both directions at the intersections of Waumsett Avenue and Pequot Avenue and stop signs on Waumsett and Pequot Avenues at Hines Road.
