Significant Events:

New guardrail/kayak (320 feet) tie-up installed at Walker Farm

• 60' of new guardrail installed & access road constructed at Community Gardens

• 300' of new concrete sidewalk was replaced on Bay Spring Avenue

Maintenance Completed:

- Twenty-Seven (27) maintenance repairs to buildings/fences/guardrail

- Ten (10) trees were trimmed & (16) removed, (14) inspected, (6) trees planted
- Seventy (70) feet of drain pipe on Rustwood Dr. was replaced
- Eighty (80) feet of drain pipe and a new catch basin was installed on Regal Point
- Twenty (20) street signs replaced
- Four hundred (400) feet of roadside cut back of overgrowth
- Various Fields were mowed by the Town's Brush hog
- Ten (10) sewer manholes inspected & (7) installations inspected
- All six (6) underground fuel tanks at the pump stations inspected

Report For: August 2019

Five hundred and seven (525) tons of refuse were collected and hauled to the Central Landfill. Previous refuse tons for AUGUST were 484 in 2018, & 500 in 2017.

The three hundred and eighty-nine (389) tons of recyclables represent forty-two (42.61) percent of the solid waste stream being recycled. Previous recycling tons for AUGUST were 377 in 2018, and 447 in 2017.

The monthly cost avoidance from recycling amounts to \$18,323.89. Revenue plus cost avoidance realize a monthly net benefit of \$20,171.76. It should be noted that effective July 1st, 2018, RIRRC increased refuse disposal rates from \$39.50 to \$47/ton.

The fiscal 2019–2020 yearly totals for solid waste as follows:
