WHEREAS: The Cumberland Town Council finds that the Town of Cumberland and the Cumberland Town Council would be better served by a change in leadership and a corresponding change from the incumbent holding the office of President of the Cumberland Town Council; and

WHEREAS: The Cumberland Town Council finds it necessary and desirable to remove Peter J. Bradley from the office of President of the Cumberland Town Council and to adopt a resolution effectuating such removal (hereinafter, a "Removal Resolution") pursuant to rules and procedures adopted by the Cumberland Town Council,

NOW THEREFORE, BE IT RESOLVED, BY THE TOWN COUNCIL OF CUMBERLAND, RHODE ISLAND, AS FOLLOWS:
